TOWN JUSTICE DAVISON - PUBLIC CONCERN:

Town Justice Davison expressed his concerns regarding the manner in which a time-sensitive health insurance matter was handled by Councilor Folts. He stated this is a gross mismanagement of representation on the part of the Town on an important employee matter due to the lack of follow-up by either Councilor Folts or the Town's insurance broker. The Bookkeeper is designated as Plan Administrator in the Employee Handbook and has always been capable of handling these affairs in the past, but this was recently changed to Councilor Folts. He feels the broker's concern is their commission and not the needs of the employees.

REPORT OF TOWN OFFICIALS:

HIGHWAY SUPERINTENDENT:

- Highway Superintendent Payne stated the Town will be receiving \$111,710.24 from FEMA.
- Jerusalem and Benton recently assisted the Village of Penn Yan on driveway maintenance repairs at their Benton Hill and West Lake Road reservoirs. Supervisor Jones will contact the Village to ascertain why the towns offer to haul road millings was declined and an outside contractor was hired instead.

TOWN ENGINEER:

- Notes of the September 15th KPSW Committee meeting are on file.

COUNCIL:

- Councilor Simmons expressed his concern with worker's compensation cost and the 2% property tax cap following a recent article in the Finger Lakes Times stating this cost will now be allocated to the Towns in Ontario County. Yates County Legislator Fitch stated this is not the situation in Yates County and noted that Jerusalem will see a significant reduction from 2011's apportionment of \$70,319.71 to \$56,529.36.
- KPSW Water Maintainer Dinehart will not be retiring in early 2012. The advertisement for the position has been placed. Applicants have to take the Civil Service test in January 2012 so a list of eligible candidates will be available at such time the position is vacated. Particulars of the position need to be determined and reflected in the KPSW 2012 Budget.

TOJ HYDROFRACK IMPACT STUDY COMMITTEE:

Co-Chair Peter Gamba presented the following:

MISSION

The Town Board of Jerusalem formed the Hydrofrack Impact Study Committee in March 2011 and tasked the committee to study natural gas drilling within the Town. The committee was charged with objectively looking at the industry's position and the anti-drilling interests in the formulation of a set of recommendations to the Town Board. The committee is formed of volunteer citizens from the Town: Jim Barre, Art Carcone, Peter Gamba, Joe Hoff, Art Hunt, Daryl Jones, Debbie Koop, Max Parson, Ed Seus, Melanie Steinberg. Peter Gamba and Melanie Steinberg were elected co-chairs.

REPORT

It has been over six months since the creation of the Committee, and the Committee has made substantial progress in meeting its goals. The Committee has met regularly and has researched the topic extensively. Its representatives have met one on one with many residents in an educational and outreach capacity; its members have met, shared research conducted independently and talked with residents and resource people on both sides of the issue. It has conducted an open forum held at Keuka College library with over 300 attendees (Natural Gas Drilling - Issues and Impact: A Balanced Discussion), conducted a community questionnaire and invited letters

from the community in which residents could state their sentiments on the topic for the consideration of the Committee, Town Board and Supervisor.

We have also sought the advice and counsel of Community Environmental Defense Council, Inc. (CEDC), a pro-bono environmental law firm based in Ithaca. We asked CEDC to prepare a first draft of an amendment to the Zoning Law that makes the changes that the Committee recommends.

As the Committee has investigated the multiple and cumulative impacts of what might be termed "unconventional gas drilling," the group has reached two primary conclusions:

- 1) The citizens of Jerusalem overwhelming support retaining the rural and agricultural character of Jerusalem and that there is a significant community sentiment against "unconventional gas drilling." The Committee believes the results of the survey support the findings of the Jerusalem Comprehensive Plan as 100% so stated on the questionnaire completed by a sampling of 178 residents (The Town of Jerusalem Comprehensive Plan emphasizes agriculture, tourism and open spaces using the asset of clean water. Do you support this emphasis in the Comprehensive Plan?)
- 2) The impacts of the natural gas extraction industry are not limited to well pad drilling, and in fact, many significant negative community impacts result from the overwhelming industrialization of an area that naturally follows extractive industry. The Committee has found that the threats to the character of the Town are not limited to "unconventional gas drilling" and the Town must move to implement the draft resolution that was delivered to the Town Board Members on September 6, 2011.

RECOMMENDATION

The Committee recommends that:

- 1) The Town revise its Zoning Law to protect the citizens of the community from the negative impacts of industrialization that follow and are associated with unconventional gas drilling,
- 2) The Town confirm and clarify that any uses that are not expressly permitted are prohibited,
- 3) Articulate certain explicitly prohibited land uses, and
- 4) Modify its use variance provisions.

The explicitly prohibited uses would be uses that are detrimental to the health, safety, and welfare of the inhabitants of the Town.

While the Committee has concluded that the specter of development of the Marcellus Shale is what led to the formation of the Committee and has mobilized the citizens of Jerusalem, the Committee has found that the threat of industrialization is much larger than simply

seeking to "ban hydraulic hydrofracturing." The Committee asks that the Town Board review the draft zoning amendment that we are presenting tonight. We recommend that the Town Board schedule and hold a public information session on the proposed zoning amendment and that the Town begin the process to adopt the zoning amendment as a local law. Members of the Committee are prepared to assist with completing the required SEQRA analysis, and other technical procedures that must be followed to adopt the local law. The Committee requests that the Town Board consider this Zoning Amendment as a high priority matter. The Committee stands by to assist in all ways possible so that this amendment may be adopted by mid-December 2011.

Co-Chair Melanie Steinberg distributed excerpts of the community letter providing the observations, comments and points of information from the Jerusalem residents.

The proposed regulations have been copied to the Planning and Zoning Boards. The local law adoption process and related time frame was discussed. Another public information meeting will be scheduled.

Whereas the water and sewer department has requested that the Town Board authorize Ted Miller of STI Company Team to install the necessary hardware to allow authorized users remote access to their desktop computers;

Whereas; the desktop computers at the Town Hall have valuable information stored on the hard drives;

Whereas upon appointment the Oath of Office is signed;

Whereas section 507 of the Employee Handbook covers Code of Ethics for all Town Employees;

Whereas chapter 17 of the Town Code covers Code of Ethics;

Whereas the Town Board by resolution has adopted the following password policy by board resolution;

Whereas any Town Employee given authorization to utilize a computer system owned by the Town will be required to create a password for that computer. This password will not be recorded in any way. No employee shall share their password. The employee will be required to change the password every 180 days. In the event that a town official requires access to town computer, they will contact the system administrator; who in turn will reset the password for their access.

Whereas; a small box would be installed on the network that would work in tandem with the firewall which would allow authorized users to connect to Remote Web Workplace (email, computer desktops, etc.) from anywhere in the world, using any computer. The connection would be very secure, using similar technology to that used by online banking, shopping, online payroll services, etc;

Whereas; the Water and Sewer Department operates seven days a week; 25 hours a day;

Whereas; remote access for the Water and Sewer Department employees would be beneficial during an emergencies, while away for training and/or conferences, or for unforeseen absences;

Whereas; the Water and Sewer Department has budgeted for computer system upgrades in the 8110.5 and 8310.5 of the 2011 budget;

Whereas; other departments within the Town of Jerusalem have expressed an interest and need for remote access;

Therefore be it resolved that Ted Miller with STI Company Team be authorized to install and update the computer systems to allow Town Employees remote access to their computers for a total cost not to exceed \$525.00; with this expense being funded evenly by 8110.5, 8310.5 and 1680.5.; and, be it further

Resolved that the standard procedure provided by our technical people will be shared with our staff.

Section 1. Pursuant to, and in accordance with, the provisions of section 617.6 (Initial Review of Actions and Establishing Lead Agency) of the New York State Environmental Quality Review Regulations (6 NYCRR part 617) the Town Board of the Town of Jerusalem hereby makes the following determinations and classifications with respect to the adoption of this local law (the "Action"):

1. That the action is subject to SEQR.
2. That the action is a Type I action.
3. That the action involves the following agencies, none of which is a Federal agency: the New York State Department of Environmental Conservation, the New York State Department of

Agriculture and Marketing, the Yates County Planning Board, the Town of Italy, the Town of Potter, and the Planning Board of the Town of Jerusalem.

4. That a coordinated review of the action will be conducted.

5. That the Town Board of the Town of Jerusalem will be the lead agency with respect to the action.

Section 2. The Town Engineer is directed to prepare a Full Environmental Assessment Form for the action (FEAF).

Section 3. The Town Clerk is directed to send copies of the Local Law, this Resolution, and the draft FEAF to each of the agencies named in item 3 above.
