## AWARD WATER REHAB PHASE 3 CAPITAL PROJECT

On a motion of Councilor Bird, seconded by Councilor Jones, the following was

ADOPTED Ayes 5 Bird, Jones, Lent, Purdy, Sisson Nays 0

Whereas the Consolidated Water District Keuka Park 2024 Improvements Capital Project was approved at an estimated cost of \$1,300,000.00, pursuant to Section 202-b of NYS Town Law via Resolution #39-24; and

Whereas said Project was advertised and bids opened on July 30, 2024. Bid results were as follows:

Contract: Phase 3 Distribution System Improvements
The proposed reconstruction project (the "Project") consists of
water main replacement consisting of approximately 5100 feet of 8inch high density polyethylene (HDPE) pipe, 1400 linear feet of
new 12-inch HDPE pipe and 1300 linear feet of new 1-inch HDPE
water service pipe, such replacements to take place on Assembly
Avenue, Central Avenue, State Route 54A and Lake Avenue. As part
of this Project, approximately 50 services will be disconnected
from the old main and reconnected to the new water main in the
same vicinity as the current services and will also be provided
with a new curb stop and curb box. This Project will also replace
8 existing fire hydrants with new hydrants and guard valves in
approximately the same location and will also install 15 new
valves at water main tee fittings allowing the Town to isolate
branches of water main on either side of the tee fittings;

# CREATE WATER AND SEWER MAINTENANCE SUPERVISOR

On a motion of Councilor Bird, seconded by Councilor Lent, the following was

ADOPTED Ayes 5 Bird, Jones, Lent, Purdy, Sisson Nays 0

Whereas a New Position Duties Statement for a Water and Sewer Maintenance Supervisor has been completed to improve operations and efficiencies in the Keuka Park Water/Sewer Department; and

Whereas said position is competitive under New York State Civil Service and exempt under the Fair Labor Standards Act (FLSA) as determined by the job duties and salary threshold;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board as follows:

- 1. The position of Water and Sewer Maintenance Supervisor is hereby created in the Town of Jerusalem and the Supervisor is authorized to sign and submit the New Position Duties Statement.
- 2. Joseph Matthews be provisionally appointed as Water and Sewer position.
- 3. That Resolution #5-24 be amended and Joseph Matthews be appointed Department Head of the Keuka Park Water/Sewer Department.
- 4. The annual salary is \$75,000.
- 5. This Resolution shall take effect immediately.

## VILLAGE OF PENN YAN INTERMUNICIPAL SEWER AGREEMENT

Supervisor Sisson updated the Board on discussions with the Village of Penn Yan to amend/renew our Intermunicipal Sewer Agreement in light of the financial implications on the capital project to install a Headworks Facility at a cost of approximately \$4M and construct a new force main at a cost of approximately \$2.18M. These improvements qualify for hardship financing at 0% interest resulting in a 7% increase in the Wastewater Treatment Plant's annual budget. Proceeding without the 0% financing would result in a 19% budget increase.

The Village provided the attached Debt Service Analysis updated to

Jerusalem Town Board Special Meeting August 7, 2024

June 2024 figures showing the financial impact if the current contracts are not extended. Jerusalem's contract expires in 2035/11 years and Milo's expires in 2042/18 years.

The Town of Milo did not attend the July 22, 2024 meeting as they are still reviewing their contract.

A summary of contract issues/comments was distributed that will be shared with the Village for further discussion.

Councilor Purdy stated a visit to the Cherry Street pump station supports the need for the project and recommends the Board tour the facility. Councilor Bird stated in the end, he wants the contract with Jerusalem and Milo to be the same.

Village of Penn Yan Intermunicipal Sewer Agreement will be placed on the August 21, 2024 Town Board agenda.

#### GRANT WRITING

MRB Group will present on services they offer to the Board at the September 18, 2024 meeting.

Councilor Lent met Joe Matthews at the Indian Pines Lift Station to check on the pump, generator and control panel installation project this morning.

With there being no further business, on a motion of Councilor Lent, seconded by Councilor Bird, the meeting was adjourned at 10:28 P.M.
